Overview



Big Blue Bus is Proposing Fare Changes to:

- Address fiscal challenges
- Support planned customer experience enhancements

Proposed Fare Changes include:

- Increased costs for single rides and passes
- Elimination of underutilized passes
- Two-phase implementation over a two-year period

No changes to:

- Free BBB transfers and contactless incentives
- Access to discounted fares on Big Blue Bus through LIFE (low-income) and GoPass (student K-12) regional programs





Fiscal Challenges

- Declining fare revenue per passenger
 - Currently \$0.70; Pre-pandemic \$0.87
- Rising operational costs
 - Currently \$182 per revenue hour; Pre-pandemic \$150
- Uncertainty of future federal funding
 - New Federal Administration

Planned Customer Experience Enhancements

- Implementation of Brighter Blue 5-Year Service Plan
- Ongoing Motor Coach Operator Recruitment & Retention
- Safety Initiatives (e.g., Transit Safety Officers, Prohibition Orders)



Recent Fare Changes

- **Fare Change in 2022**
 - Conclusion of Contactless Pilot
 - Introduction of Free BBB to BBB Transfers
 - Introduction of 10 Rides Pass
 - Elimination of paper passes
 - Increase age for free rides from 4 to 5 years old
- **Fare Change in 2017**
 - Contactless fare (i.e., TAP) reduced to \$1.10 (from \$1.25)
 - Introduction of Annual Pass
- **Fare Change in 2016**
 - Last fare increase
 - Increased Regular Single Ride fare from \$1.00 to \$1.25
 - Other fare increases across the board

Proposed Fare Changes

Increase cost of Regular and Senior/Disabled/Medicare (SDM):

- Single Ride
- 1-Day Pass
- 7-Day Pass (Available only for Regular)
- 10 Rides Pass
- 30-Day Pass

Eliminate:

- Annual Pass (Regular)
- Youth 30-Day Pass

Maintain:

- Free BBB to BBB transfers
- Cheaper fares on TAP and Mobile

Single Ride (Tap & Mobile) ^	\$0.50	\$0.60	\$0.65
Single Ride (Cash)	\$0.50	\$0.75	\$0.75
1-Day Pass	\$1.50	\$1.75	\$2
10 Rides Pass^	\$4.50	\$5	\$6
30-Day Pass	\$24	\$27	\$30

^Includes one free Big Blue Bus to Big Blue Bus transfer within 2 hours.

Youth	Current	August 10, 2025	Summer 2027
30-Day Pass	\$19	Eliminate	-

Discounted Fare Programs

- Low-Income Fare is Easy (LIFE)
- GoPass
 - K-12 Schools (SMMUSD and LAUSD)
 - Community Colleges (Santa Monica College)
- UCLA Bruin U-Pass and Grad Pass
- Access Services



Alternatives Considered

- **No Fare Increase**

- Risks not implementing full Brighter Blue service enhancements (e.g., frequency improvements, early/late and weekend service)
- Risks Motor Coach Operator recruitment and retention efforts, and safety initiatives

- **Elimination of Free Transfers**

- Results in increase in fare revenue, but limited impact on fiscal challenges
- Decision to maintain:
 - Proven to increase ridership
 - Reduces burden on low-income riders



Financial & Budget Impacts



Fully implementing proposed changes:

- Increases revenue by about 13 percent or \$780,000 annually
- Increases Average Fare per Rider to 85 cents by 2028
- Projected ridership decline of 7 percent
 - Actual ridership and revenue impacts may vary due to other factors such as:
 - Economic trends
 - Service quality
 - Demographic changes
 - Alternative transportation options

Future Enhancement: Open Payments

- Big Blue Bus participating in LA Metro's 'TAP Plus' Initiative
- Onboard fare payment via credit/debit card or Apple/Google Pay expected in 2026

- **Present Proposal to City Council for Approval – May 13, 2025**
- Notify Riders and Community – May to August 2025
